**1. Organizing Authorities**

The organizing authority is the Bayshore Gardens Yacht Club

**2. Rules**

This regatta will be governed by the current Racing Rules of Sailing (RRS) and the West Florida PHRF Class Rules. This is a category 5 event per WFPHRF class rules for the race in the Bay. Random Leg Rating will apply.

**3. Eligibility**

The regatta is open to all WFPHRF boats. PHRF Fleets include: Spinnaker, Non-Spinnaker, Cruiser, Pocket Cruiser & Multihulls.

**4. Registration & Fees**

**4.1** Registration is \$25 per boat. Registration fee includes complimentary refreshments at Skippers/Registration meeting.

**5. Ratings and Class Rules** Boats sailing in the PHRF fleets must have a valid WFPHRF certificate and have a copy of the certificate available. Rating certificates are available online at [westfloridaphrf.org](http://westfloridaphrf.org). All boats must carry applicable U.S. Coast Guard required equipment. In the event that there are insufficient entries for a given class, classes may be combined.

**7. Sailing Instructions**

Sailing Instructions will be available at the skippers' meeting. The race course will utilize the SSS compass rose markers.

**8. Scoring**

One race constitutes a regatta.

**9. Courses**

There will be one Pursuit race, with possible separate course for Multihulls.

**10. Prizes** Awards will be given out according to the number of registrants in each class.
